You are invited to apply for a space in the next Alaska-Juneau Public Market, Thanksgiving weekend, Friday through Sunday, November 27, 28 & 29, at the Juneau Centennial Hall and the Public Market Annex at the Juneau Arts & Culture Center (formerly the Alaska National Guard Armory).

We will not make space assignments prior to August 1, 2009. We will mail/email notice of your application status by August 8, 2009.

At this time, we are only soliciting applications. Following the initial assignments, vendors will receive an invoice with an application for tables, table skirting, and other equipment. Your assignment will be confirmed upon receipt of payment in full (refunds are prompt). We'll also provide participating vendors with further information about the Public Market, including our promotional plans.

Both the Centennial Hal Public Market and the Public Market Annex will be open to the public from noon to 8 p.m. on Friday (Nov. 27), and from 10 a.m. to 5 p.m. on Saturday and Sunday (Nov. 28 & 29).

Vendors may set up their booth displays on Wednesday, Nov. 25, from 5 p.m. and 9 p.m., (we are closed Thanksgiving Day, November 26) and from 8 a.m. to 11 a.m. on Friday morning.

SELECTION CRITERIA

At Centennial Hall, we charge admission; at the Public Market Annex in the Juneau Arts & Culture Center, no admission is charged. We are selective for applicants who prefer a space assignment at the Public Market in Centennial Hall, while applicants for the Annex are assigned primarily on a first come/first served basis.

For Centennial Hall applications we give preference according to the following criteria:

1) High quality products/services available "Only at the Public Market!" 2) Good food (we can always use more good food!). 3) If your product is commonly available in Juneau, describe how your presentation or products are unique to the Public Market — unique presentations might include creative/interactive booth designs; special product discounts; author/artist available for signings "Only at the Public Market" — or anything that is markedly different from a vendor's retail outlet or space at local arts & crafts shows.

It is possible the product and service you intend to offer simply does not meet with our goal of presenting a unique Christmas shopping experience for our customers who pay to enter Centennial Hall. Until the Public Market Annex is full, assignment at this "no admission charged" venue will be available to all applicants. Any vendor assigned to the Annex will have the opportunity to be listed for reassignment to Centennial Hall. We have a high rate of success with reassignments.

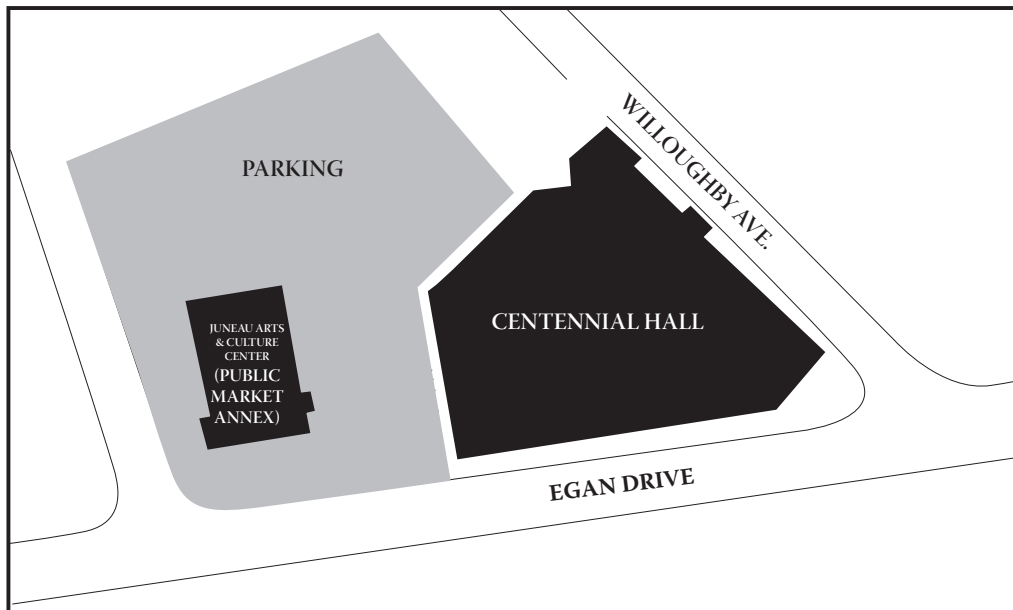
